### **PUBLIC SCHOOLING IN UNCERTAIN TIMES**

The post-pandemic era has seen a notable return to 'normalcy', but certain atypical factors continue to influence our district's operations. While student social and emotional needs remain acute, district personnel have made tremendous gains in helping our learners overcome the trauma and isolation of recent years. Similarly, missed learning is gradually being addressed, and with some increased investment in academic remediation, we are confident that COVID's educational impact will continue to fade.

As with most sectors of the economy, inflation is a central factor in our district's fiscal operations. While New York State has calculated the rate of inflation for school districts for the past year at 8%, we are pleased to offer a budget proposal which features a spending plan

well-below that rate of increase. As in past years, this budget proposal reflects a projected tax levy which, at 2.05%, is compliant with tax cap/tax levy limit regulations and therefore requires only a simple majority voter approval.

Next year's instructional and co-curricular program is envisioned as stable, with a few notable additions. The expansion of the Mathematics Department at Plattsburgh High School will enable the offering of extra academic intervention services to further assist students in recovering from pandemic missed learning. In recent years, our City has featured an increasing population of English Language Learners, and the addition of one Teaching Assistant to scaffold instruction will better enable the district to meet this growing need. Finally, as the demographics of our faculty change (with over 50 new Teachers and Providers hired between 2021 and 2023 in response to high retirement rates), the


need for mentorship and the development of newer educators is increasing. The district plans to expand opportunities to develop and cultivate strong professional practice in its new hires, and this budget reflects increased funding for such. Otherwise, this budget features the perpetuation of the excellent programming for which our district is renowned.

As was announced last year, the May 2023 Budget Newsletter has been disseminated electronically. We are grateful that you've taken the time to access this information and to learn about the details of the proposed 2023-24 Plattsburgh City School District budget, which will be offered for voter approval on May 16, 2023.

#### **FEDERAL STIMULUS FUNDS**

As you know, all school districts currently receive federal stimulus funds through the Corona Virus Response and Relief Supplemental Appropriations Act (CRRSA) and the American Rescue Plan Act of 2021 (ARPA). This funding extends through Summer 2024 and is enabling the district to best address student learning and emotional needs while positioning itself

financially for an anticipated recession and State Aid constraint following the expiration of these funding streams.

Students and parents will have noted a broad slate of extension learning opportunities (Summer programming, after-school clubs, and certifications, etc.).

District personnel strongly encourage families to avail themselves of these opportunities while they are offered.

#### **VALUE-ADDED THROUGH COLLEGE EQUIVALENCY OFFERINGS**

Did you know that Plattsburgh High
School students have access to 34 collegeequivalency courses (102 total credits) as
part of their regular, daily course selections?
Students may receive credit through either
Advanced Placement (AP) from the College
Board or College Advanced Placement
(CAP) through Clinton Community
College, both at highly-discounted tuition
rates. While not all college equivalency

offerings may appeal to all students, and not all courses are accepted at all colleges, Hornet students regularly graduate from PHS with one full year or more of college credit, which represents significant savings in overall college expense. # Projected Annual Tax Impact of the 2023-24 Budget

The tax impact estimates to the right do not assume any change in the total taxable assessed value for the City. This total valuation will not be known until June. Any increase in total taxable assessments will decrease the tax rate.

\*Note: These estimates do not reflect any exemptions (ie. STAR). Each taxpayer should further consider those exemptions for which they qualify.

# BOARD ELECTIONS & STUDENT EX OFFICIO BOARD MEMBER

Brief descriptions of candidates for Board of Education seats are

listed here www.plattscsd.org/district/board-of-education/boe-election/ or by scanning the QR code at right. This year, there is an additional measure for voter consideration — one which involves the creation of a student ex officio Board position. New York State Education Law allows Boards of Education to include, with voter



approval, the inclusion of a non-voting student member. Beyond not voting on action items, the Student ex officio Board member also does not participate in executive session.

Generally then, the role of the student ex officio Board member is to advise the larger Board of Education about student perspectives. There are established criteria which the Superintendent and Board must use in selecting the specific student representative, notably that the individual must be a Senior at Plattsburgh High School, having attended that school for two years, and serving on the representative Student Government (in this case, the PHS Student Association).
