**Report:** School Budget Hearing – Superintendent Lebrun reported there are no significant cuts and that notable additions entail the purchase of a school bus, and the re-introduction of a special education program at Stafford Middle School, which will require a Teacher, a Teaching Assistant, a small number of Student Aides and possibly a School Psychologist. The Superintendent reported the Tax Levy is 2.03% which is under the tax cap. He noted that the District is excited about the grant programs and stated that details about the parameters and time of this stimulus are still emerging.

The Superintendent noted there are not any other propositions on the ballot; just the approval of the budget and the election of School Board members. There are 8 candidates running for four seats. He reminded everyone the budget vote/board election is May 18, 2021 and that people can vote via absentee ballot and in-person. The State has temporarily amended so as to also allow voting by absentee ballot, for those who feel uncomfortable voting in-person due to COVID concerns. For those who are voting in-person, please remember to wear your masks and to maintain social distancing.
