**SPOT LIGHT:** Footbridge Designation – Anne Bailey spoke favorable in name the footbridge after Thelma Douglas, acknowledging many of Thelma's accomplishments and interactions with students. Ms. Bailey also shared a letter from Dan LaDue supporting the naming of the bridge after Thelma.

It was moved by Mr. Sherman, seconded by Mr. Morris to approved the following resolution: WHEREAS **Thelma Douglas** began teaching Physical Education across the entire Plattsburgh City School District in 1944 and was often seen bicycling gym class equipment from school to school and,

WHEREAS **Thelma Douglas** became the first woman in New York State to become a Director of Health, Physical Education and Recreation a role in which she successfully received a federal grant for her program "Movement Education" to the Plattsburgh City School District's elementary education and,

WHEREAS Thelma Douglas consistently and regularly introduced and promoted life-long activities such as bicycling, snow shoeing, ice skating, cross-country and down-hill skiing, hiking, camping and swimming to the students of the City School District and,

WHEREAS Thelma Douglas was one of the founders of the Beartown Ski Area ("Mother of Beartown") and initiated down-hill skiing instruction for grades 4-12 and,

WHEREAS Thelma Douglas (Miss D.) was inducted into the Plattsburgh High School Hall of Fame in September of 1988 and,

WHEREAS Thelma Douglas served on and headed many local committees that were focused on both the physical and mental health of both the children and adults of the City of Plattsburgh and,

WHEREAS the footbridge that crosses the Saranac River behind Plattsburgh High School and makes a pedestrian connection between Waterhouse Street and Angell Drive is solely owned by the Plattsburgh City School District therefore

BE IT RESOLVED to honor her dedication to both the students and community the Plattsburgh City School District Board of Education on this 22<sup>nd</sup> day of June 2021 officially names this bridge as the "THELMA DOUGLAS FOOTBRIDGE" and be it further,

RESOLVED that the school district will install appropriate signage noting such recognition and be it further,

RESOLVED that the Superintendent of Schools and/or the Clerk of the Board of Education notify the appropriate public authorities to make such changes as necessary.
