He agrees having that many teachers out on the Friday is a concern. Mr. Hall inquired on sub salary comparisons. He wished everyone Happy Holidays - Enjoy your family.

Ms. Phillips suggested maybe making Fridays after a holiday a Supt's. Day. She wished everyone Happy Holidays.

Ms. Gervich welcomed staff to invite the Board to their activities/events. She is interested in getting creative in getting sub teachers for our students. Ms. Gervich wished everyone a Happy Hanukkah stating she looks forward to seeing everyone in the New Year.
